

Terms and Conditions

These terms and conditions are applicable for the "Test Ride Registration" Contest, which shall be referred to as "Contest" henceforth. The Contest is being conducted from 02.11.2015 to 20.11.2015. Participation in the Contest is purely voluntary.
